Northwest HIDTA

- Initiative budgets account for approximately 20% of the total Northwest HIDTA budget
- Drug Court Initiative: 10 partner agencies \$390,000 budget
- Prevention/Public Education Initiative: 10 partner agencies \$510,000 budget
- Fiduciary: Educational Service District 105

I-502 Key Elements

- Legalized system of producing, processing and retailing cannabis for adults age 21 and older
- Legalized possession of:
 - 1 ounce of useable cannabis for smoking
 - 16 ounces in solid form
 - 72 ounces in liquid form
- No consumption in public or in public view
- No home grows (except for registered medical patients)
- Imposed an excise tax rate of 37% on retail cannabis sales (not including 10% sales tax)
- Public Safety and Education
 - Established a Delta 9 THC blood threshold for cannabis DUIs
 - Limits store locations, advertising and number of outlets
 - Earmarked revenue for healthcare, prevention, education and research

I-502 Implementation Update

 I-502 passed in 2012; retail stores opened in 2014; "medical dispensaries" were closed in 2016


- Of 229 cities and towns in WA State
 - 109 have passed or already allowed permissible zoning
 - 81 have enacted prohibitions
 - 39 have taken no action
- Of the 39 counties in WA State
 - 30 have passed or already allowed permissible zoning
 - 6 have enacted prohibitions
 - 3 have taken no action

•The LCB has licensed 473 stores (266 with medical endorsements)

•The LCB has licensed 1,090 producers and 1,178 processors


Daily retails sales exceed \$4 million

WA State Marijuana Production






Past 30 DAY MARIJUANA USE

- A total of 392 crashes were reported:
 - 37 resulted in a fatality, 22 caused serious injury, 110 resulted in minor injuries – most involved 2 vehicles
- Most crashes occurred on I-5, followed by I-90 and I-82
- Most crashes occurred between 4-5 pm and on Saturdays

Short changing the promise of marijuana legalization






